Summary Annual Report for the ITPEU Pension Plan

This is a summary of the annual report for the ITPEU Pension Fund, (Employer Identification No. 11-2506736, Plan No. 001) for the period October 1, 2020 to September 30, 2021. The annual report (Form 5500) has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Basic Financial Statement**

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$18,337,897. These expenses included \$1,913,826 in administrative expenses and \$16,424,071 in benefits paid to participants and beneficiaries. A total of 41,970 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$158,055,742 as of September 30, 2021 compared to \$147,840,410 as of October 1, 2020. During the plan year the plan experienced an increase in its net assets of \$10,215,332. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$28,553,229, including employer contributions of \$12,044,186, losses of \$965,206 from the sale of assets and earnings from investments of \$17,472,493 and other income of \$1,756.

## Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
