Summary Annual Report for the ITPEU Annual Benefit Fund

This is a summary of the annual report for the ITPEU Annual Benefit Fund, (Employer Identification No. 11-2823324, Plan No. 501) for the period April 1, 2020 to March 31, 2021. The annual report (Form 5500) has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$5,087,829 as of March 31, 2021 compared to \$4,214,194 as of April 1, 2020. During the plan year the plan experienced an increase in its net assets of \$873,635. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$10,434,536. This included employer contributions of \$9,146,622 and earnings from investments of \$1,272,129. Plan expenses were \$9,560,901. These expenses included \$815,955 in administrative expenses and \$8,744,946 in benefits paid to participants and beneficiaries.
