Summary Annual Report for the ITPEU Pension Plan

This is a summary of the annual report for the ITPEU Pension Fund, (Employer Identification No. 11-2506736, Plan No. 001) for the period October 1, 2019 to September 30, 2020. The annual report (Form 5500) has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$16,427,541. These expenses included \$1,841,420 in administrative expenses and \$14,586,121 in benefits paid to participants and beneficiaries. A total of 38,914 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$147,840,410 as of September 30, 2020 compared to \$142,543,430 as of October 1, 2019. During the plan year the plan experienced an increase in its net assets of \$5,296,980. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$21,724,521, including employer contributions of \$11,391,381, gains of \$1,280,106 from the sale of assets and earnings from investments of \$9,053,034.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An accountant's report;
2. Assets held for investment;
3. Transactions in excess of 5 percent of the plan Assets; and
4. Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
